

# OFFICIAL RULES & REGULATIONS

**1. How to Enter: NO PURCHASE NECESSARY / FACEBOOK ENTRIES ONLY.** The Snyder's of Hanover® "National Pretzel Day Celebration" Sweepstakes ("Sweepstakes") begins on Facebook at 12:01 p.m. Eastern Time ("ET") on April 9, 2014, and ends at 11:59 p.m. ET on April 20, 2014 ("Sweepstakes Period").

You may enter by visiting Snyder's of Hanover® Pretzels Facebook Page at [www.facebook.com/snydersofhanover](http://www.facebook.com/snydersofhanover), clicking on the Sweepstakes tab, and completing and submitting an entry through the Sweepstakes application during the Sweepstakes Period, including your name, email address and date of birth. You must be a fan of the Snyder's of Hanover® brand page to enter the contest. No other method of entry is permitted. Limit of one entry per person throughout the entire Sweepstakes Period. No mechanically reproduced or automatically generated entries are permitted. Incomplete, illegible, or garbled entries will be disqualified. There will be no verification of receipt of entries. If you enter using a mobile device, standard data charges may apply from your carrier.

**2. Eligibility:** To enter the Sweepstakes you must be a legal resident of any of the 50 states or the District of Columbia and be 18 years of age or older as of the date of entry. Sweepstakes is void outside of the aforementioned states and where restricted or prohibited by law. The Sweepstakes, and any website pages and advertisements relating thereto, are intended for viewing only within the United States. Employees of Snyder's-Lance, Inc., GKV, and their respective parent companies, subsidiaries, affiliates, advertising, promotion agencies, and the directors, officers, employees or agencies, and any of their respective partners or prize suppliers, their affiliated companies, parents, subsidiaries, and advertising and promotion agencies, (collectively, "Sweepstakes Entities"), and their immediate families (defined as spouse, mother, father, in-laws, grandmother, grandfather, brother, sister, children and grandchildren) and members of their households, are ineligible to participate in this Sweepstakes. Void where prohibited.

**3. Drawing and Notification:** Beginning on or about April 12, 2014, Sponsor and/or GKV will randomly select twenty (20) prize winners on each of these dates (April 12, April 16 and April 21) from among all eligible entries received as of 11:59:59 p.m. ET the previous day before the drawing. Winners will be randomly selected using the Wildfire Winner Selector. Non-winning entries carry over into subsequent drawings. Decisions are final and binding in all respects. Odds of winning a prize depend on the number of eligible entries received as of each drawing date. Potential winners will be notified via the email submitted in the entry form within 10 days following the drawing. If an email notification is returned as undeliverable, or if a potential winner is discovered to be ineligible or otherwise in violation of these Official Rules, then such person shall be disqualified, and an alternate winner will be selected from among the remaining

eligible entries received. Winners must sign and return a Declaration of Eligibility and Liability/ Publicity Release (“Declaration”) within the timeframe indicated in order to formally claim the prize.
